Singapore Children's Society is celebrating our 65<sup>th</sup> Anniversary and we will be conducting our 65<sup>th</sup> Anniversary Conference from 24<sup>th</sup> - 25<sup>th</sup> November 2017.

The Singapore Children's Forum will take place on Day 2 of the conference. As with the previous children's forums held in 2013 and 2015, our third Singapore Children's Forum continues to provide our children a platform to dialogue, discuss and express their opinions on issues that mattered to them.

The theme of this year's forum is "What Makes You Shine". We hope to hear from the children (aged 10 to 12 years old) on what success means to them and the factors that are necessary to attain success.

To lead up to the children's presentation of their views on 25<sup>th</sup> November, there will be a 3 days pre-forum orientation from 21 - 23 November 2017. The details are listed below. Please note that your child will have to attend all 3 days of the Pre-forum orientation and the actual Forum.
