





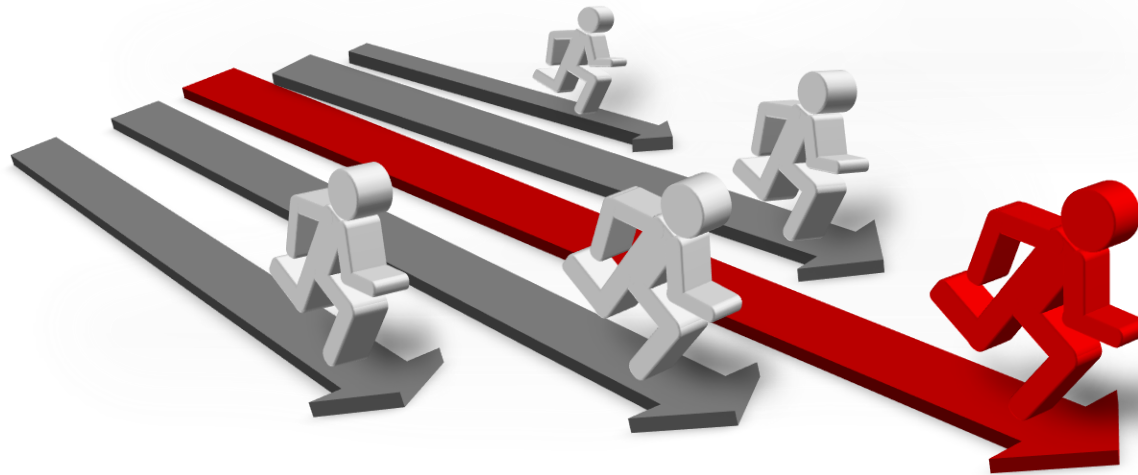
3. Sponsorships (Others)
